Making Procurement Manual for a Central Government Ministry. The consultant will be required to attend meeting in the Ministry & AJNIFM. Drafting and writing the chapters in consultation with all state holders will be the responsibility of the consultant.

#### 3. Tenure:

2.1 The tenure of the Consultant/Research Associate is of a temporary nature and for a period of three months only. The appointment can be cancelled at any time by the Competent Authority of AJNIFM without assigning any reasons.

#### 4. Other entitlements/Conditions:

#### 3.1 Remuneration

#### 3.2 Tax deduction at Source

Income tax or any other tax liable to be deducted, as per prevailing rules will be deducted at source before effecting the payment for which AJNIFM will issue a TDS certificate

#### 5. Confidentiality:

The Consultant/ Research Associate may not, except with the previous sanction of AJNIFM in the bonafide discharge of his/her duties, publish a book or a compilation of articles in a radio broadcast or contribute an article or write a letter to any newspaper or periodical, either in his/her own name or anonymously or pseudonymously in the name of any other person, without the prior approval.

B. During the period of assignment with AJNIFM, the professionals would be subject to the provision of Indian Official Secret Act, 1923 and shall not divulge any information gathered by him/her during the period of his/her assignment to anyone who is not authorised to know/have the same.

C. The professionals appointed by the Institute shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of AJNIFM.

i) The Consultant/ Research Associate is unable to address the assigned works ii) Quality of the assigned works is

not to the satisfaction of AJNIFM iii) The Consultant/ Research Associate fails in the timely achievement of the

milestone as finally decided by AJNIFM iv) The Consultant/ Research Associate is found lacking in honesty/integrity

or violates the confidentiality clause

v) The consultancy cannot be terminated by the Consultant/ Research Associate during the fixed term of the Consultancy
