About the Program

> Program Background

A significant amount of public funds is allocated to the procurement of government hospital requirements, for which specific rules and procedures have been established. It is crucial that doctors involved in public procurement directly or indirectly, especially those in decision-making roles or serving as members of the Committees, are well-versed in these guidelines to ensure procurement of various goods and services in most efficient, cost effective and transparent manner.

Ministry of Finance, Government of India has identified AJNIFM as the nodal agency for conducting training programs on procurement with a view to educating and familiarizing the concerned executives/officers with all the relevant rules and procedures of Public Procurement. AJNIFM has been conducting these training programs regularly since 2015 and receives active support from Public Procurement Policy Division of Ministry of Finance, Government of India in this regard.

> The Program Objectives

- AJNIFM offers very high quality training for all types of public procurement, viz., goods, works and consulting services using GeM platform or outside the GeM. The Institute has vast experienced resources for designing and delivering the training programs in this regard for all types of organizations, cadres and units of officers.
- This **special** Training Program is designed to equip Government Doctors, who are directly or indirectly involved in the process of procurement (both as a buyer or as a user) with the knowledge and skills necessary to effectively manage public procurement, ensure compliance, and contribute to the achievement of national health objectives using efficiently the limited funds available on their disposal.

> The Program Contents

The program coverage would include:

- I.GFR Fundamental Principles
- **II. Procurement Process**
 - a) Procurement Cycle
 - b) Defining the Specifications (Special Qualitative Requirements)
 - c) Methods of Procurement
 - d) Drafting of EoI, Bid Documents, Contract, etc.
 - e) Legal issues in Procurement
- III. Procurement through GeM including detailed hands-on practice sessions
- IV. Practical cases relating to Health Sector procurement.

Pedagogy and Faculty

The pedagogy of the program is a mix of lecture, discussion, case studies and practical sessions on computers available exclusively for each participant, etc. Ample opportunities shall be provided to the participants to discuss the issues faced by them and share their experiences and learn from the experience of the experts and the other participants. The faculty comprises of AJNIFM's internal faculty members and leading experts from the relevant areas.

> The targeted participants

The program is designed to meet the needs of Doctors from Central and State Government Hospitals, involved directly or indirectly (either as buyer or user) in the public procurement function.

> The Program duration and dates

The program is residential and of 3 days duration.

The program shall start in the morning of Monday (30.06.2024) from 09:30 A.M. and would complete at 05:30 P.M.on Wednesday (02.07.2024). The participants should make their travel arrangements accordingly.

> The Program Venue

- The venue of the program is Arun Jaitley National Institute of Financial Management (AJNIFM), Sector 48, Pali Road, Faridabad 121001, Haryana.
- It is located in Faridabad town on Badkhal-Pali Road, about 1.4 km south of Badkhal Lake crossing.
- AJNIFM is at a distance of about 30 kms from India Gate, New Delhi and about 35 kms from Delhi Airport. The nearest metro station is Badhkal Mor. Participants may reach AJNIFM one day before commencement of the programme and proceed for their return journey after conclusion of the programme on the same day or the next day.

Program Fee & Payment Procedure

- The fee in respect of the nominees from <u>Central or State Government Hospitals which</u> are functioning as a part of the <u>Ministry/ Department (non-autonomous) is</u> ₹30,000/-per participant
- The fee in respect of the nominees from Government <u>Hospitals running as an Autonomous Organisation (like AIIMS)</u>, is ₹30,000/- per participant (**plus** GST @18%).
- The fee includes course fee, boarding, Certificate and free access to library, computer lab, Gym, sports and other facilities. However, it does not include to and to fro journey to AJNIFM.
- The bank details for online transfer of fee is given in <u>Annexure I</u>.

> Program Capacity

- 30 (thirty). The nominations shall be accepted on FIRST COME FIRST SERVE basis.
- In the event of excess nominations received, the nominees may be considered in the next program.
- Confirmation of acceptance of nomination from AJNIFM shall be sent by e-mail in respect of those nominees whose fee is received and nomination are found acceptable.
 Only such nominees who have received confirmation from AJNIFM shall be allowed to join the program.
