- Urban ageing, disability, and intersectionality
- Access to health, nutrition, and care services in urban settings

5.TRACK V: EDUCATION, SKILLS, AND DIGITAL TECHNOLOGIES IN URBAN CONTEXTS

- Urban education systems and skill ecosystems
- Gender dimensions of the urban digital divide
- Technology-enabled solutions for gender-inclusive urban development

6.TRACK VI: CLIMATE CHANGE, SUSTAINABILITY, AND URBAN RESILIENCE

- Women, climate vulnerability, and urban resilience
- Gender and sustainable urban environmental practices
- Climate-responsive urban planning and disaster risk reduction
