About the Program

Program Background

With the advent of economic liberalization, deregulation, and consequent globalization, financial-related inputs have become more critical to management decisions. A modernday executive operating in a highly competitive environment and aspiring to assume a more effective role in decision-making process would, therefore, do well to possess sufficient insight into the intricacies of financial issues. A proactive role in decision-making requires of finance and various related concepts so that s/he can objectively, and in a professional manner, evaluate alternative courses of action. Simple reading of financial statements does not give insight and hidden strength or weaknesses of an organization. Therefore, analysing the financial statements and comparing them in different periods and for benchmarking with the similarity placed organisation becomes indispensable.

> <u>The Program Objectives</u>

The program is intended to give the in-depth knowledge of analysing the financial statements of a commercial organisations/ undertakings (Private or Government). This will give an excellent opportunities to the participants to learn the various techniques useful in analysing the financial statements of an entity.

> <u>The Program Contents</u>

The program coverage would include:

- i. Understanding Financial Statement
- ii. Analysis of Financial Statement
- iii. Ratio Analysis, Trend Analysis, Common Size Statement Analysis
- iv. Technique of Capital Budgeting & Cost of Capital
- v. Efficiency or otherwise in the management of Working Capital and Cash.

Pedagogy and Faculty

The pedagogy of the course is a mix of lectures, case studies and hands-on-exercises. Opportunity shall be provided to the participants to share their experiences. The faculty comprises of AJNIFM's internal faculty members and leading experts from the relevant fields. At the end of the program the participants shall be put to take a test to assess the effectiveness of transfer of learning through this program.

> <u>The targeted participants</u>

The program is designed to meet the needs of middle and senior-level officers from Central and State Governments, PSUs of Central and State Government and Autonomous Bodies/ Institutions involved directly or indirectly in preparation, studying and analysing the financial statements of a commercial organisation in the decision making process.

The Program duration and dates

The program is residential and of 3 days duration.

The program shall start in the morning of Monday (20.05.2024) from 09:30 A.M. and would complete at 05:30 P.M.on Wednesday (22.05.2024). The participants should make their travel arrangements accordingly.

The Program Venue

- The venue of the program is Arun Jaitley National Institute of Financial Management (AJNIFM), Sector 48, Pali Road, Faridabad 121001, Haryana.
- It is located in Faridabad town on Badkhal-Pali Road, about 1.4 km south of Badkhal Lake crossing.
- AJNIFM is at a distance of about 35 kms from Delhi Airport and about 32 Kms from New Delhi Railway Station. The nearest metro station is Badhkal Mor.
- The Participants may stay at AJNIFM one day before commencement of the program and one day after conclusion of the program.

> Program Fee & Payment Procedure

- The fee in respect of the nominees from <u>Central or State Government Ministries/</u> <u>Departments/ Attached/ Subordinate Offices is</u> ₹ 30,000/-.
- The fee in respect of the nominees from Autonomous Bodies/ PSUs and other organisations of Central or State Governments is ₹ 30,000/- per participant plus GST @ 18%.
- The fee includes course fee, lodging, boarding and access to library, computer lab, Indoor sports complex with Gym, Yoga Room and out-door sports facilities, etc. However, it does not include to and to fro journey to AJNIFM.
- The bank details for online transfer of fee is given in <u>Annexure I</u>.

Program Capacity

- 30 (thirty).
- The nominations shall be accepted on FIRST COME FIRST SERVE basis.
- In the event of excess nominations received, the nominees shall be considered in the next program.
- Confirmation of acceptance of nomination from AJNIFM shall be sent by e-mail in respect of those nominees whose fee is received and nomination are found acceptable. <u>Only such nominees whose nominations have been confirmed by AJNIFM shall be allowed to join the program</u>.


