The terms and conditions of the auction are as below:

- 1. The materials offered for disposal is on " as is where is" basis in different lots of items.
- 2. The detailed list of the material to be auctioned will be available with Junior Engineer (C) / Assistant Engineer (E), AJNIFM and materials can be inspected during office hours from 03:00 PM to 04:30 PM before the last date of auction.
- 3. The purchaser may inspect the materails in presence of representative of AJNIFM
- 4. All the bidders will have to deposit a sum of Rs. 10,000/- (Rupees Ten thousand only) in cash as an earnest money before taking part in the auction which shall be refunded to unsuccessful bidders after the auction is over. As soon as the auction is over, the earnest money will be refunded to the unsuccessful bidders.
- 5. The highest bidder will have to deposit 25% amount of bid at the fall of the hammer and the remaining 75% amount is to be deposited to the Accounts Office, NIFM, Faridabad within 3 days after issue of the acceptance letter of bid, failing which 25% amount already deposited will be forfeited.
